### STATEMENT

The Procter & Gamble Company, a corporation duly organized under the laws of the State of Ohio, and located in the city of Cincinnati, in the county of Hamilton and State of Ohio, whose principal office is located in the Gwynne Building, northeast corner of Sixth and Main Streets, Cincinnati, Ohio, has adopted and used the trade-mark shown in the accompanying drawing, for BAR SOAP—NAMELY, FOR TOILET AND BATH—in Class 4, Abrasive, detergent, and polishing materials, and presents herewith five specimens showing the trade-mark as actually used by applicant upon the goods, and requests that the same be registered in the United States Patent Office in accordance with the act of February 20, 1905, as amended.

The trade-mark has been continuously used and applied to said goods in applicant's business since March 15, 1945.

The trade-mark is applied or affixed to the goods, or to the packages containing the same, by placing thereon a printed label on which the trade-mark is shown, and in other ways customary to the trade.

Applicant is the owner of Trade-Mark No. 137,644, dated November 30, 1920 renewed to applicant.


